Entries must be submitted on DVD format. Entries must have been completed between 2007 and 2009.

The call for entries deadline is July 2nd, 2009.

Please mark the DVD and case with the title of your film, running time, your name and contact information.

Also include a synopsis. Additional publicity materials are welcomed.

Entry Fee

Submissions should arrive with an entry fee of \$35.00.

Deadline Submissions must be postmarked by the entry deadline Friday, July 4th, 2009. Participants will be informed by August 29th, 2009 of their status.
